- 1. Rain over 1-inch per hour
- 2. Wind greater than fifty (50) miles per hour
- 3. Hail larger than 1 inch—quarter-size or larger
- 4. Flash flooding—rapidly rising flowing water into areas that do not typically flood.

If there any stations with minimum reporting criteria please come now with your unit number.
