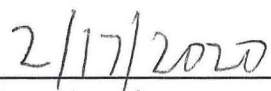
Resolution No. 21

CORPORATE RESOLUTION 25

“Change Membership Dues”

In accordance with Article 7.7 of the *By-Laws*, on **June 12, 2025**, the Membership of the Metrocrest Amateur Radio Society, Inc adopted a resolution to change our dues structure and rate as follows:

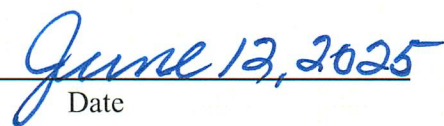
1. The Senior and Junior discounts shall be eliminated.
2. The dues for a “Full” membership shall be \$30 per year.
3. The dues for an “Associate” membership shall be \$15 per year.
4. The effective date for new and renewal memberships shall be July 1, 2025.

All eligible members were sent a copy of the resolution for their consideration. Early/absentee voting was conducted between May 8, 2025 and June 12, 2025, via HamClubOnline.com. **Director Dave Lane, N5GDL reported we had 53 votes: 48 “yes”; 5 “no.” The resolution passed.**
